ELECTRIC INFRASTRUCTURE SAFETY

ou may have seen reports on the news this past year about several attacks on electric substations and other electrical infrastructure around the country. Some of those attacks have resulted in extended outages for thousands of consumers and damages costing millions of dollars. Sometimes the goal of these attacks is purely destruction, mass outages and mayhem. Other times — and this is what we have primarily seen at Southeast Colorado Power Association (SECPA) — copper theft is the main goal of the attackers. SECPA has experienced several instances of theft over the past few years, including thieves breaking into substations and stealing spools of cable and thieves cutting and stealing ground wires off substation structures and power poles. Cutting and stealing ground cables off of energized structures and lines is an extremely dangerous practice that is expensive to repair. It can cause major power outages and, most significantly, can have deadly consequences if contact with energized wires occurs during the theft. Ironically, most of the cable used in SECPA's power system is not copper, but rather aluminum and steel that have little salvage value.

Like any utility, SECPA is concerned about the physical security of our electrical system. We have installed security cameras at many of our facilities and taken other security measures, but our first line of defense is you: our members who live, work, and play near our power lines and substations.



You may not realize that SECPA's service territory is so large. We serve members in 11 different counties across southeastern Colorado in a territory spanning 13,000 square miles. We maintain nearly 5,800 miles of power lines and more than 20 substations and switching facilities. That

substations and switching facilities. That is a lot of territory to cover and a lot of facilities to watch. With limited staff, we simply cannot be everywhere throughout our system at the same time. That's why we need you to help keep an eye out for any suspicious activity you may see at or near our power lines and substations. If you see something suspicious or just want to verify that we have crews working in an area, please call us at 800-332-8634 any time of the day or night.

One thing to look for is individuals who aren't easily identifiable as SECPA employees working in or around our substations, facilities or power lines. SECPA linemen will almost always be wearing clothing with the SECPA logo and driving vehicles that also have the SECPA logo. An exception is contract crews. SECPA sometimes uses contract crews for line repairs and construction, as well as tree trimming and pole inspections. They work for SECPA, but are not in SECPA vehicles or clothing.

If you question if people are working for SECPA, if you see anything suspicious, or something doesn't look right, give us a call to verify. And if you see an actual break-in or theft occurring, please call 911. You may be preventing an outage affecting you and your neighbors.

Income Summary

Purchased Power is SECPA's largest expense; in 2022 it accounted for 58.4% of revenues. The increase is attributable to higher sales levels.

Operating Expenses were steady or below 2021 levels; SECPA experienced fewer and less severe storms in 2022.

Non-Operating margins and subsidiary income were higher in 2021 due to non-recurring PPP loan forgiveness.

Balance Sheet Summary

SECPA assets continue to grow; SECPA's work plan includes roughly \$5,000,000 per year in system improvement projects.

Equity as a percent of assets is strong for SECPA. It was 58.9% at the end of 2022.

Strong performance allows for more significant capital credit retirements. The Capital Credit Retirement processed this month is the largest in SECPA history.
