4. Board Meeting Minutes

Motion was made and seconded to approve February 16th, 2022, Board meeting minutes. MOTION carried.

5. Interim Chief Executive Officer - Brandon

- Kiosk for SECPA member payments has been installed at the pharmacy in Eads (advertising to inform members that kiosk is available for payments.)
- Kent Singer, CREA Executive Director, has asked to attend a Board meeting (possibly invite him for May meeting.)
- Brandon explained how SB22-090 (Severe Weather Notifications to Utility Customers) and SB22-110 (Equip Wind Turbine Aircraft Detection Lighting System) could affect cooperatives.

6. Accounting & Finance- McBrain

- January Income Statement, Balance Sheet, various graphs & check Register were reviewed. (Included in Board packet.) McBrain mentioned that A & G line item on Monthly Margins & Expenses was higher due to \$60k to replace roof on Pueblo West building (will be reimbursed by insurance) and also, employee payouts.
- January Net Margins, \$138,237; YTD, \$\$138,237.
- McBrain presented a new format for Equity graph.
- Wright asked the status of the Rate Study. McBrain replied that it is progressing, may have assumptions by June or July and study completed in August.

7. Member Services & Technology - Brandon

- Membership reports included in Board packet. Net loss of 16 accounts.
- \$29,147k YTD delinquent charges; 10% delinquent bills.

8. Operations - Hall

- Various kWh graphs, Outages, Work Order, and Line Loss reports reviewed (included in Board packet.)
- Monthly line loss was equivalent to \$60,281.
- Sold more power this year than last year for the same time period.
- Closing out Work Orders related to storm.
- Four employees and Metering Manager are attending Rocky Mountain Metering School in Fort Collins this week.
- Kinder Morgan has paid to build 7 miles of 3 phase West of Kim to a compressor station; paid by credit card.
 Discussed fees for credit card payments. Rushton asked if we need a policy for credit card payments. Brandon will follow up.
- A trencher Hall had considered purchasing from Vermeer of Colorado increased in cost from \$55K to \$65K. Hall has found a trencher in Clinton, Illinois with ½ number of hours for \$50k; may travel there to purchase.

- Hall explained that a truck that was budgeted this year; if ordered now, would not be delivered until 2023. Hall is requesting quotes.
- Hall & Mike Trumble are attending Operations Conference in crested Butte in April.

9. Human Resources - Bamber

- February payroll = \$355,364 (overtime = \$4,912); and other payroll \$16,109 (includes employee paid time off payout at resignation); 49 employees.
